

How do I become a Covenant Club member?

Our Covenant Club is composed of individuals who have made an outright or planned gift to the Covenant to Care for Children in one of the following ways:*

An outright gift of cash to our Endowment - In this way, each member assures the future of Connecticut's most at-risk children.

An outright gift of appreciated assets - This is when you contribute such items as stock or property owned for longer than one year

A life insurance gift - Naming CCC as a beneficiary of your insurance policy creates the possibility of a large future gift.

A gift through your will - You may wish to consider including CCC in your will or living trust. This allows you to set aside a fixed amount, specific asset or percentage of your estate as a bequest.

A gift made through a charitable trust or annuity - Creating a charitable trust or annuity provides life income for yourself and/or others, with your gift eventually directed to CCC.
